SINGLE TOUCH PAYROLL

The tax office has moved businesses who employ more than 20 staff to online wages reporting. From 1 July 2019 the Tax Office wants all other employers to do the same. The legislation is before parliament at the moment and it is very likely to be passed. For any business with one employee or more, in addition to reporting wages paid on your BAS and reporting super paid through a Superstream provider, the ATO now want you to report all your wage, PAYG tax withheld and superannuation information each time you process your payroll. For some businesses this will mean an upgrade of their current bookkeeping software to allow the payroll information to be sent to the ATO. For the very small employers, the ATO are currently working with 31 software providers to develop some cost-effective programs to enable very small businesses to be compliant and to report without incurring huge costs. We are currently looking at the software available and hope to advise a solution that we think will best suit you, our clients. Please note, if you already have a bookkeeping software like Xero, MYOB or Quicken you will already have the software to be able to comply with Single Touch Payroll requirements.

SMSF DEED UPDATES

With the massive amount of changes in superannuation legislation and recent court case findings, we have received legal advice that SMSF deeds need to be reviewed and updated to ensure ongoing compliance with SIS legislation and ATO requirements. As such, in Feb 2019 we will be writing to you about Deed upgrades for your SMSF Deed. We are working with a number of providers at the moment to establish both a) a broad-covering, up to date deed; and b) a cost-effective deed upgrade package for Complete Commerce clients.

TWO FACTOR AUTHENTICATION

In order to increase cyber security and protect your data, the ATO has begun to introduce mandatory two factor authentication for some cloud accounting software. Two factor authentication adds extra security to prevent unauthorized access to your system by getting you to provide multiple pieces of information to authenticate yourself. This might be by sending an sms to your phone or using Google Authenticator. With fraudsters becoming increasingly sophisticated with their attempts to breach your system, it is important that steps are taken to protect the data of your employees, your clients and your business. In the new financial year Complete Commerce will be introducing a portal to you to electronically access your financial statements and tax returns to be compliant and keep your information safe.
