#### **NEW RESIDENTIAL PREMISES**

The ATO have had a lot of problems administering tax debts on building companies over the last decade. As such they have now put some rules in place to make sure that they don't miss out on the GST component of each sale. In most circumstances, the sale of a newly built residential premises will have GST on the sale as the ATO considers such a sale to be a business transaction (profit making intention) and not a capital gains event. As such, the ATO now makes the purchaser pay 10% GST to the government rather than paying it to the seller and letting the seller send it on to the ATO. This means the ATO gets the full 10% (or 7% if the taxpayer has elected to use the margin scheme) and then any adjustments can be made on the appropriate BAS. This is another way the ATO are trying to make sure they get what they are entitled to. Although it is a pain administratively, it won't actually affect the financial position of taxpayers who are following the rules correctly.
