REZONING TAX FOR VICTORIANS

From 1 July 2023, a windfall gains tax applies to all land rezoned where the rezoning results in in an increase in value of the land of more than \$100,000. The tax is due when the rezoning occurs but you can apply to defer the tax until you sell the property. If you have a block of land that is rezoned this is something you need to look at. It's a nasty tax imposed by the Victorian Government to try and claw back some of our State's debts.
